Terms and regulations for publishing in the Journal

Afaqeqtisadia Journal is a peer-reviewed scientific journal concerned with publishing original scientific research and studies in the field of economic sciences. It is issued semi-annually by the College of Economics and Commerce at Elmergib University, and its publication controls are as follows:

The Journal's vision and interests:

Afaqeqtisadia Journal publishes peer-reviewed scientific research and studies in the field of economic and political sciences in Arabic, English, and French. The magazine focuses on research that is concerned with issues related to the national economy in terms of analyzing the problems that concern this economy and proposing appropriate policies to deal with them with a neutral scientific vision committed to an approach. Scientifically, it aims to develop the spirit of creativity and develop scientific research tools and methods in order to emulate contemporary scientific developments.

The Journal also provides room for publishing critical comments on recently published books, especially recent and important international books, and allows each of these comments a space of no more than a page and a half, provided that these comments are characterized by objectivity and deep analysis to show the merits of these books in order to benefit from them.

The Journal also publishes reports on scientific seminars and conferences, allocating space for each of these reports not exceeding three pages during which the objectives and topics of this or that symposium or conference are stated, as well as brief summaries of the most important scientific papers presented during it and its most important recommendations, with the necessity of mentioning the title of the symposium or conference, its date, and the place of its holding.

1. Conditions for publishing in the Journal:

2-1 Conditions for artistic direction of the research:

- 2-1-1 Requirements for submitting the research: The research must be printed on the computer on paper (17 x 24).
- 2-1-2 Writing font: Research in Arabic is written in Traditional Arabic font, size 14 for the body, size 15 bole for main titles, and size 14 bold for subtitles. The numbers mentioned in the research are written in Traditional Arabic font, size 12, and research is written in English or French. In Times New Roman, size 12 for the body, size 13 bole for main titles, and size 12 bold for subtitles.
- 2-1-3 Page Margins: Page margins shall be as follows:

First: the right (2.5 cm).

Second: Left (2.5 cm).

Third: the highest (1.5 cm).

Fourth: Bottom (1.5 cm).

- 2-1-4 Line spacing: (single space for Arabic, and one and a half spaces for English or French).
- 2-1-5 Alignment of paragraphs: (total adjustment).
- 2-1-6 Paragraph spacing (6 points before and after the paragraph).
- 2-1-7 Page numbering is at the bottom of the page on the left and is not written on the cover page.
- 2-1-8 The parts of the research are numbered according to the following system:

2-2 Reference to footnotes and references:

The Harvard style system is followed in referring to all the sources and references that the researcher cited in his research in the following manner:

2- 2-1 Reference to references in the body of the research: References are made to the sources and references that the researcher cited in his research in the body of the research (marginalization within the text), as in the following example.

(Al-Desouki, 2009, p. 12)...(Title, year of publication, page)

The following points are taken into account:

First: If there is more than one author, the marginalization will be as follows:

(Al-Desouki & Hindi, 2006, p. 10)

Second: If there are more than two authors, the marginalization will be as follows:

(Al-Desouki et. al., 2006, p. 10)

Third: In the event that there is more than one reference to the author, the references are arranged in alphabetical order (abjadhuz) as follows:

(Al-Desouki A, 2006, p. 10)

Fourth: If more than one page or a specific range of pages is quoted, it will be marginalized as follows:

(Al-Desouki et. al., 2006, pp. 10-12) This is when the quote is taken: from pages 10 to 12.

(Al-Desouki et. al., 2006, pp. 10, 12) This is when the quote is taken from pages 10 and 12.

2-2-2 The reference list is written at the end of the research according to the following criteria:

First: It must be arranged in ascending alphabetical order from A to Z for English references).

a-Books

b- Periodicals:

Stanlic, Robert (2008), "Economic growth un Libya", International Economics, (January), 20-33.

c- nternet sources and references: written as follows:

2-3 Methodological conditions for writing research:

- A. The research must be original in its ideas and topic.
- B. The research must provide a new scientific contribution (theoretical or applied), and must not be merely a compilation and narration of well-known scientific ideas.
- C. Commitment to the recognized scientific method in writing scientific research.
- D. Integrity of language, clarity and coherence of ideas.
- E. H. The research must not have been previously published or submitted for publication in any other journal, and the researcher must provide an acknowledgment of this.
- F. The research submitted for publication in the journal must not be derived from a master's thesis or a doctoral thesis prepared by the researcher.
- G. The researcher writes a summary of no more than 250 words, which is written in English for research written in Arabic, and the summary is written in Arabic for research written in English or French.
- H. The researcher fills out and signs the form related to intellectual property rights.
- I. Mathematical symbols and equations (if they appear in the search) are inserted by using the (Insert Equations) tool in the MS Word printing program, or by using any other program known to deal with mathematical symbols.

2-4Mechanism for evaluating materials submitted for publication:

- 1. The materials published in the magazine shall not exceed 20 pages for working papers and shall not exceed 30 pages for research.
- 2. All research and studies submitted for publication are subject to a confidential and precise scientific evaluation by two arbitrators in the field of specialization, and only research and studies that receive a positive evaluation are published.
- 3. The evaluator must have at least the rank of assistant professor, and the evaluator must have a higher academic degree than the researcher in all cases.
- 4. The decision to publish depends on the recommendation of the two arbitrators. In the event that the evaluation results differ such that one of the two arbitrators recommended publication and the other recommended against it, a third arbitrator will be referred to, whose decision is considered final.
- 5. The negative opinions of the arbitrators shall not be taken into account unless they are scientifically justified and justified.
- 6. The researcher will be officially notified of the arbitration decision within a maximum period of two months from the date of receipt of his research.
- 7. The researcher will be notified of the required amendments, if any, and he will make them within a period not exceeding one month from the date he is notified of them.
- 8. Research accepted for publication is displayed on the citation program. Research with a citation rate of 30% or less is accepted for publication, while research with a citation rate above this rate is rejected, even if it is accepted by the referees.

2-5- General considerations:

1. Research and studies shall be sent in three hard copies and a CD in the name of the magazine's editor-in-chief, or sent to the magazine's e-mail.

2. The researcher's name, academic degree, current place of work, and address are written on the research cover, including phone number and e-mail.

- 3. Research sent to the journal will not be returned to its owners, whether published or not.
- 4. The opinions expressed in the research and studies published in the magazine express only the opinions of their authors, and they alone are responsible for the points of view they contain and the validity of the information or data contained therein.
- 5. The magazine does not publish more than one research by the same researcher in the same issue, even if one of the research is jointly with one or more other researchers.
- 6. The journal does not publish research co-prepared by more than three researchers.
- 7. Research and studies are published according to the date they are received in the journal, taking into account diversification in content to include all scientific specializations in the college and taking into account the priority of publishing applied research that is concerned with the local Libyan environment and which can be used to provide solutions and treatments for local institutions.
- 8. The published research is arranged according to considerations of the artistic direction of the magazine, and this arrangement does not reflect the value of this research or the level of its authors.
- 9. The researcher shall be provided with three copies of the journal in which his research has been published.
- 10. Publishing in the journal is free, and there are no fees associated with publishing in the journal.
